WAIVER OF LIABILITY, RELEASE AND ASSUMPTION OF RISK
[PLEASE READ BEFORE SIGNING]

IN CONSIDERATION OF _____ [Name of Player], being allowed to participate in any way in Triangle Girls Church Basketball Association (the "Association") related events and activities (collectively referenced herein as "Association Activities"), the undersigned acknowledges, appreciates, and agrees that: I understand the risk of injury is significant, including the potential for injury and/or death to player or other players. I understand the risks to include, but not be limited to injuries from running, jumping, stretching, sliding, colliding with other players, referees or stationary objects, throwing or being hit by a ball. I understand there are other risks that are not known to me or reasonably foreseeable at this time.

I agree that the Association and the Released Parties (defined below) are not responsible for these and other unexpected risks or occurrences not reasonably foreseeable at this time, and that I will participate in the Association Activities under this Agreement at my own risk. **I knowingly, voluntarily, freely, and expressly choose to incur all risks associated with Association Activities.**

In consideration of being allowed to participate in Association Activities, for myself, parents, legal guardians, heirs, executors, and my administrators, **I do hereby forever waive, release, fully discharge, and agree not to sue the Released Parties (as defined below) from any and all claims, liabilities, actions, or causes of action of any kind or character whatsoever arising from, connected in any manner with, or as a result of my participation in Association Activities, whether arising from the negligence of Released Parties or otherwise, to the fullest extent permitted by law.** I understand that, should I decline to execute this Agreement, I will not be permitted to participate in Association Activities.

The "Released Parties" shall mean the Association, including its, members, managers, officials, employees, coaches, representatives, volunteers, and agents.

By signing below, I acknowledge and agree that I have carefully read this Agreement, and fully understand its contents. **I am aware that this Agreement contains a release and waiver of all my rights and claims for damages that I (and others claiming through me) may have that exist now or may arise in the future as a result of injury to my person or property, or my death, or any other risks that I may sustain by engaging in Association Activities.**

I further agree that no oral representations, statements, or inducements apart from the foregoing written agreement have been made. The laws of the State of North Carolina shall govern the interpretation and construction of this Agreement.

BY SIGNING BELOW, I ACKNOWLEDGE AND AGREE THAT I HAVE READ THIS WAIVER OF LIABILITY, RELEASE AND ASSUMPTION OF RISK, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
